## Candidate Biographies and Ballot



**Greg Cope, Candidate, President-Elect** - Greg is Assistant Professor and Department Extension Leader in the Department of Environmental and Molecular Toxicology at NC State University. He received a B.S. in Environmental Sciences in 1983 from

Lenoir-Rhyne College in Hickory, NC, a M.S. degree in Biology with emphasis in aquatic sciences from the University of Wisconsin-La Crosse in 1988, and a Ph.D.

with a double major in Fisheries Biology and Toxicology from Iowa State University in 1991. Greg's experience prior to coming to NC State includes work as a fisheries technician with Duke Power Company Environmental Laboratories in Huntersville, NC, while an undergraduate student at Lenoir-Rhyne College and as a research fishery biologist with the U.S. Geological Survey's Upper Midwest Environmental Sciences Center in La Crosse, Wisconsin for the first six years after obtaining his doctorate. His interests and expertise are in the effects of anthropogenic stresses on aquatic organisms, with emphasis on fish and invertebrates, the bioavailability, fate and transport of pollutants in aquatic ecosystems, and public outreach and education. He's been an AFS member since 1985 and has been active in two divisions and three state chapters. He has served the AFS as Associate Editor of the Transactions, member of the Publication Awards Committee, Student Awards Committee, Resource Policy Committee, and Outreach Committee at state, division, and society levels.



**Mallory Martin, Candidate, President-Elect** - Mallory is Mountain Region Fisheries Supervisor for the NC Wildlife Resources Commission. He was educated at NC State and earned a master's in fisheries at Virginia Tech. He began his career with the Wildlife

Resources Commission as a fish culturist at Armstrong State Fish Hatchery in 1984, before assuming the district fishery biologist position in Waynesville. Mallory then served as Fish Hatchery Program Coordinator in the mountain region, a position he held for many years. His current responsibilities include administration, personnel management, and policy development. He is a certified fisheries scientist, certified public manager, and has been active in AFS for more than 20 years.

### Proposed Bylaws Revisions

The NCAFS Executive Committee has unanimously recommended proposed changes to the Chapter Bylaws to incorporate recommendations from the 2001 ad hoc Awards Committee. According to our Chapter Bylaws, "proposed amendments to the Bylaws shall be circulated in writing to the membership at least 30 days prior to any regular meeting at which a vote is to be taken. Such amendments shall pass upon approval by a two-thirds majority of the members present at any regular meeting,

provided a quorum is present". The proposed changes may be viewed at <http://www.sdafs.org/ncafs/BylawsRevision2003DRAFT.pdf>. The purposes of the changes are summarized below:

1. To change the name of the Best Student Paper to the "Richard L. Noble Best Student Paper" and clarify when the award is presented.
2. To change the W. Don Baker Memorial Award to recognize the best presentation by a fisheries professional which removes student papers from consideration for this award. It also clarifies when the award is presented.
3. To empower the Chapter newsletter editor, after consultation with the Chapter President, to send noteworthy articles to Fisheries and the editor of the Southern Division AFS newsletter.
4. To add the Awards Committee to the list of Chapter standing committees and delineate their responsibilities, including, selection of judges for best student and best fisheries professional papers, establishing and reviewing judging criteria and selection of recipients for other Chapter awards.

Note that the most significant change alters the eligibility for the two best paper awards. Currently, students are eligible for the W. Don Baker Memorial Award. This change would allow only fisheries professionals (non-students) to be considered for this award.

All comments will be summarized and available at the business meeting on Friday, February 14, 2003 when we vote on the proposed changes.

### **News from around North Carolina**

**AFS News from President Fred Harris** - The North Central Division had a successful meeting in December, modeling it after the Southern division's spring meeting. Normally the NCD meets as part of the Midwest Fish & Wildlife Conference. This year the host province



backed out and the meeting was cancelled. The NCD decided to go it alone and hosted the Midwest Fisheries Conference. The 350-400 people who attended heard some interesting, well-prepared presentations on numerous topics. Mike Duvall was there with no discernable changes in his energy level or his demeanor.

The steering committee of the Uses of Propagated Fishes in Resource Management Symposium met at the Midwest Conference. This is going to be an important event for those involved in the use of hatchery fishes in management programs. It's a sequel to the Albuquerque meeting that was held several years ago. AFS continues its leadership in resolving this issue and I encourage you to attend. The Symposium is set for June 16-18 in Boise, ID. Check the AFS web site for details.

Work is progressing on the development of a Fisheries Foundation to support AFS projects. Dale Burkette and John Epifanio are co-chairs of the Committee that's working on the Foundation. Several major contributors have been identified who will be invited to serve on the Foundation's Board of Directors. An early focus of the Foundation will be on outreach. More details will be forthcoming in a President's Hook Column this spring in Fisheries.

Call for Papers - The American Fisheries Society (AFS) will convene its 133rd Annual Meeting at the Québec City Convention Center in downtown Québec, 10-14 August 2003. The meeting's theme is Worldwide Decline of Wild Fish Populations. The theme addresses the identification and explanations of potential factors that may be contributing to the decline of marine and inland fish populations. The scientific program will include 3 types of sessions: Symposia: accepted proposals from individuals or groups of oral presentations or posters around a common theme. Submit by 23 December 2002. Contributed Papers: accepted abstracts of oral presentations by individuals or groups organized and scheduled into sessions by the Quebec Program Committee. Submit by 20 January 2003. Posters: accepted abstracts for posters displayed to facilitate discussion between presenters and attendees. Submit by 20 January 2003. ### **Spotlight on Oldtimers and Young Professionals**

*Spotlight on Frank McBride, NCWRC* - The Wildlife Resources Commission hosted a party in Nash County last month recognizing the retirement of the Fish Division's Frank McBride whose last official work day was 29 November. It was easy for those in attendance to find complimentary things to say about Frank's long and stellar career. It was less easy for his old field buddies to avoid telling embarrassing work war stories, but most tried valiantly and succeeded!

Frank was raised in Wilmington, NC, and graduated from UNC Wilmington in 1972. He began his career with the Wildlife Resources Commission as a fish technician living in Lewisville working for Roy Miller, mostly at Belews Lake. Some thought the agency needed a big intimidating guy that grew up in North Carolina to help Cornell trained Roy meet his work objectives in that part of the state. Frank enjoyed the work, but it was too long a trip from Winston-Salem to the coast every weekend during duck season so he asked for and got a lateral transfer near Rocky Mount where he worked as an Assistant District Biologist. The job and the quail and deer hunting there suited him just fine, and it was closer to those coastal ducks.

Frank was promoted to District Fisheries Biologist in the area in 1977 where he did a lot of reservoir fisheries management, logged time on the Roanoke River with striped bass management and production at Weldon, and did some important work on the Eno and Tar rivers working with Roanoke bass and its habitat. He quickly developed a reputation as a dependable pragmatic biologist and the toughest guy on the field crew despite Roger Jones' frequent unsuccessful attempts to mount a challenge. He was also refining his skills as a supervisor handling his district assistant biologist. Frank was a stickler for being on time and is reputed to have barged into another Jones' home to pull him from his bed when he slept past an agreed upon start time for a day in the field.

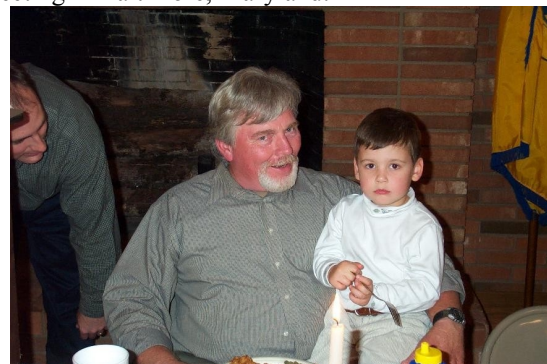
In 1988, Frank accepted the new challenge of Assistant Division Chief coordinating the agency's fisheries management program. The same combination of common sense, pragmatism, integrity, and fairness was now benefiting not just District 3 and the Piedmont Region, but the whole Fish Division. Perhaps one of the more notable landmarks in this work period was his leadership in the decision to purchase the commercial hatchery that would become the Watha State Fish

Hatchery. After a technological fix for an unanticipated well water gas saturation problem that caused him some heartburn and self doubt, the hatchery has greatly increased the Commission's warm water fish production capacity and its service to anglers. He also found time to serve as president of the NC Chapter of AFS.

Frank assumed the role of environmental supervisor in 1994. Some of his friends thought the job change might have been a desperate attempt to avoid a daily commute into the center of Raleigh from his quiet home in rural Nashville. Reflecting on his accomplishments in the new position, most now concede it is possible Frank saw the habitat losses occurring because of development in his home state and decided he could influence that process as environmental supervisor. Hydropower relicensing on the Roanoke River, reservoir shoreline management, watershed restoration work in the mountains, and mitigation funding for white shad restoration in the Roanoke River are among the larger projects heavily influenced by Frank's leadership. He has worked hard to give the Commission a strong role to play as government defines how habitat is going to be affected by development in North Carolina. The Southeastern Association of Fish and Wildlife Agencies recognized Frank's professional accomplishments by naming him their Biologist of the Year at its recent meeting in Baltimore, Maryland.

Frank, we thank you for your friendship and your service to the state, both its natural resources and its citizens. It was a pleasure working with you and we wish you well in your retirement.

**Spotlight on Larry Olmsted, Duke Power Co.** - "My intention coming out of graduate school was to just stay a few years, get some experience, and then move on", Larry Olmsted often remarked about his job as Director of the Scientific Services Unit of Duke Energy Corporation. Twenty-nine years later Larry is retiring after an illustrious career that, under his guidance and example, saw the development of the biological investigations at Duke into one of the premier electric utility scientific programs in the US.

Larry received his BS from Northwest Nazarene College in Nampa, ID and his MS and Ph.D. fisheries training from the University of Arkansas. A long time member of and advocate for the AFS, Olmsted has served the Southern Division as president and vice-president. He also was instrumental in the reorganization and support of the NC Fishery Workers Association; the precursor of the NC Chapter of AFS. At the 2002 AFS annual meeting in Baltimore, Olmsted was awarded the Meritorious Service Award for his significant and long lasting contributions to the Society.

Anyone who ever met Larry and spent any time with him realized immediately that he is progressive thinker. Not only is he well-versed in freshwater fisheries issues,

but is able to integrate fishery science into pragmatic watershed-level decision making. Larry could talk environmental issues with not only professionals in the field, but just as easily with CEOs and corporate officers. Because of his extremely strong interpersonal skills and his ability to deliver the services he promised, he was extremely adept at receiving private, governmental, and corporate funding to grow fisheries and ecosystem level investigations around the Southeast. His direction, his vision, but just as importantly his caring and strong ethical commitment, will be very much missed by his many many friends and colleagues across the country.

**Research Experiences for Undergraduates at Miami University, Ohio** - Miami University is pleased to announce a Research Experiences for Undergraduates (REU) site, funded by the National Science Foundation and Miami University. The REU site will provide support for 12 undergraduate students per year to conduct research in ecology and environmental science.

The site focuses on collaborative research on the Ecology of Human-Dominated Landscapes. Thus, students will be immersed in research projects that relate to society's impact on ecosystems, and each student will conduct an individual research project within a team of other students & faculty.
