#### North Carolina Chapter of the American Fisheries Society 2020 Awards Committee Report Submitted by Greg Cope and Corey Oakley February 17, 2021

Due to the Covid-19 pandemic and associated restrictions on travel and in-person meetings, the NCAFS Chapter did not administer the Student Travel Award Program or the Undergraduate Student Travel Award Program in 2020-2021. Likewise, because of the continued pandemic and virtual meeting platform for the 2021 annual meeting of the North Carolina Chapter of the American Fisheries Society, the Jerry R. Finke Distinguished Service Award and the Fred A. Harris Fisheries Conservation Award were deferred until the next possible in-person meeting.

For the 2021 annual meeting, the Committee recruited judges and conducted the judging for the W. Don Baker Memorial Best Professional Presentation Award. There were 10 full-length presentations made by professional members. The professional presentations were judged by Tom Kwak, Corey Oakley, and Greg Cope. The Richard L. Noble Best Student Presentation Award was not presented in 2021 because there were no full-length presentations made by students.

The 2021 W. Don Baker Memorial Best Professional Presentation Award was presented to Casey A. Grieshaber of the North Carolina Wildlife Resources Commission for her presentation entitled "Winter trout stocking in Piedmont impoundments and changes in angler effort". Her presentation was co-authored by Lawrence G. Dorsey.

#### North Carolina Chapter of the American Fisheries Society 2020 Communications Committee Report Submitted by Brena Jones February 10, 2021

The Chapter website (<a href="https://nc.fisheries.org">https://nc.fisheries.org</a>) saw 6,586 page views in the past year, from 2,121 users. The most popular pages, after the Chapter meeting pages, were the officer & awards pages, as well as the dynamic <a href="calendar of fisheries and ecology conferences">calendar of fisheries and ecology conferences</a> across the US.

We again successfully hosted both annual meeting registration and officer voting online, as well as having membership registration continually available. The listserv distributed newsletters, job announcements, news items, and calls for information to 316 participants. Many thanks to the Parent Society of AFS, who hosts our website and content at no charge to NCAFS. Four quarterly newsletters were distributed to the Chapter in 2020. Those newsletters were comprised of 34 contributed articles (not including the President's message, good work, etc.) in 51 pages of printed material. These newsletters would not have been possible without the contribution of the many chapter members who contributed material, as well as the newsletter committee (Brena Jones, Morgan Raley, and Bryn Tracy).

#### North Carolina Chapter of the American Fisheries Society 2020 Awards Committee Report Submitted by Seth Mycko February 23, 2021

In 2020, the NCAFS Education and Outreach Committee coordinated an occupancy modeling and estimation workshop lead by Dr. Krishna Pacifici of the NC State University Quantitative Ecology Lab. The workshop had 33 attendees and was held online January 12-13, 2021. COVID-19 limited other activities in 2020.

#### North Carolina Chapter of the American Fisheries Society 2020 Awards Committee Report Submitted by Ben Ricks February 22, 2021

The Environmental Concerns Committee (EEC) was tasked with polling the membership's opinion on the "Let Them Spawn" bill after the 2020 business meeting. The membership was polled for guidance to see if NCAFS should support this bill. Only 31 members completed the form with 65% supporting, 29% did not support, and 7% abstained. EXCOM and ECC did not feel then level of participation warranted action. Additionally, support for developing a statement supporting sound science in coastal fisheries management was 100% and EXCOM tasked the ECC to have this done by the 2022 meeting.

In addition, a motion to dissolve the ECC and process environmental concerns by having the president appoint chapter members to handle each issue as they arise passed at the 2021 business meeting. Procedures on how to handle each issue will be added to the bylaws by the 2022 business meeting

#### North Carolina Chapter of the American Fisheries Society 2020 ad Hoc Mentoring Committee Report Submitted by Kevin Dockendorf February 25, 2021

The NCAFS Ad Hoc Mentoring Committee was formed at the 2020 NCAFS Chapter meeting in New Bern.

The Covid-19 pandemic constrained activities during much of spring and summer 2020.

Virtual conference options such as Zoom and Microsoft Teams allowed for committee chair to attend and participate in the AFS Diversity and Inclusion day, Minorities in Natural Resources Conversation (MINRC), and NCSU Student Fisheries Society meetings to actively listen to needs of undergraduate and graduate students in the fisheries and wildlife conservation careers.

Committee members corresponded via e-mail and inquired "Who's our audience?". Research of available data in the NC Tower database was evaluated. Analysis of undergraduates in the Natural Resources and Conservation program from 10 UNC Public University systems revealed an exponential increase in B.S. graduates between 2003 and 2019. In 2019, there were 644 graduates and another 1,900 juniors and seniors in line to graduate from those universities. This conservation career has long been considered highly competitive, yet the number of graduates and upperclass students seeking job openings and internships during a pandemic was quite humbling.

In fall 2020, Committee chair Dockendorf coordinated with NCAFS webmaster Jones to develop a webpage for the mentoring committee. With this committee webpage established, mentoring information along with committee agendas and meeting recordings could be posted here as well.

On December 7, 2020, Mentoring Committee members met with a small group of undergraduate students for a virtual listening session to consider "Mentoring Mondays", planned committee events to occur quarterly each year on Mondays. This session was recorded and is available on the committee webpage for review.

On Monday, February 15, 2021, NCAFS and NCSU SFS hosted a student-mentor workshop as a virtual opportunity to meet with undergraduate and graduate students and anyone interested in a conservation career. This event was hosted on Zoom by NCSU and was held in collaboration with the NCWRC Partnership for Inclusion – Relevancy Roadmap Implementation Grant and fostering the next generation of conservation professionals. This collaboration provided six panelists, six moderators and 29 attendees, including 4 high school students, to meet and converse. Pre-registration was voluntary and included an opportunity for students to provide questions for panelists ahead of time. Panelists were selected to represent public, private and academia sectors. This meeting was recorded and is available on the NCAFS Mentoring webpage.




